**Tuition** The teacher is responsible for regular cello tuition. Tuition begins on \_\_\_\_\_ with no set limit. The tuition takes place in the teacher's music room: Gulmstrasse 60, 6315 Oberägeri.

Tuition is given as single lessons in weekly lessons of \_\_\_\_\_ minutes.

The tuition semesters correspond with the length of the school semesters at the Canton Zug state schools. The teacher offers at least 17 lessons per semester. Each lesson after this is included in the price. The first semester begins after the summer holidays and ends at the beginning of the sports holidays. The second semester begins after the sports holidays and ends at the beginning of the summer holidays. Tuition does not take place on official cantonal holidays and in the holidays of Canton Zug state schools.

**Fees** The fees for one semester amount to CHF \_\_\_\_\_ and can either be paid in full in advance by the 1<sup>st</sup> of the month or monthly in 6 equal payments of CHF \_\_\_\_\_. Since the monthly payments have been calculated on a year's basis, payment is also due in the holidays.

**Cancelled lessons** The teacher is not obliged to compensate for lessons cancelled or missed by the student and these lessons cannot be deducted from the fees. If tuition is cancelled by the teacher, and the full 17 lessons are not given, the due amount will be reimbursed pro rata. The amount for each lesson is calculated by dividing the fee you paid for the semester by 17.

**Length of contract, termination** This contract can be terminated at the end of the month by both contractual partners. Termination must be given in writing by the first of the month. On termination of the contract, the fees already paid will be balanced with the number of lessons given and any amounts owed by either of the parties will be paid / billed. If one of the contractual partners does not wish to continue the contract after the trial period, it suffices for this to be communicated in the last lesson of the trial period.

**Other** If a student wishes to play in events, ensembles, competitions or sound recordings prior approval must be obtained from the teacher; the same applies for auditions.
